Explanation on using Matrix for Riverside-San Bernardino County Indian Health, Inc.

Designated staff member will review application, verify household income, household size, and vulnerable population to determine how many points theapplicant is potentially eligible for. Gas and electric are original bills from the utility company, propane vendors produce estimates to fill or a bill from a recent delivery, and wood requires two estimates; in some cases one estimate is acceptable.

For Example

If there is a family of 4 with two children under six and a gross monthly income of \$2,500, the household will be eligible for \$450 (8 Points) of utility assistance.

If there is a household of 1 that is 56 years old with a gross monthly income of \$1,500, the household will be eligible for \$425 (7 Points) of utility assistance.

Crisis assistance is provided to eligible houehold under 60% SMI, in the amount of \$500.00

-Shut-off notice or when a regular heating or cooling assistance has been exhausted.

The following situations are defined as life threatening crisis:

When the heating in winter or cooling in summer has been shut-off and the applicant has a medical condition or illness that requires the use of utility services such as: medical equipment or medication requiring to be refrigerated. The program will pay for deposits, reconnection, and utility costs up to a maximum of \$850. Approval for this type of life-threatening crisis assistance must be obtained from the Chief Executive Office or designee.
